<sup>(</sup>a) Compiled in the framework of the production of the consolidated balance sheet of the monetary financial institutions (Regulation ECB/2021/2), these statistics show, as compared with the Annual Accounts, some differences in presentation and in scope. Therefore, although coins in circulation are not a liability of MFIs in the participating Member States, but a liability of the central government, coins are part of the monetary aggregates and this liability is to be entered under the category 'currency in circulation'. The counterpart to this liability is a claim on the Treasury and is included within 'remaining assets' (here under the item 'Not broken down by geographical area').

The total of the balance sheet at end-2022 published in March 2023 (1 883.9 bn) can be calculated by subtracting from the total of the Monthly Monetary Statement at end December 2022 (1 889.4 bn): coins (4.1 bn) and miscellaneous amounts linked to the accounting gap between the statement established in early January 2023 and the Annual Accounts, which include all the year-end entries (1.4 bn).

<sup>(</sup>c) Extra euro area deposits have been reallocated to French MFIs and French 'other sectors' (2017-2022).

<sup>(</sup>d) Since January 2002, banknotes in circulation are treated according to specific euro area accounting conventions to bring them in line with the capital key share. 8% of the total value of euro banknotes in circulation is allocated to the European Central Bank. The remaining 92% is broken down between the NCBs in proportion to their share in the paid-up capital of the ECB.
