Interest rates on bank deposits - France • June 2023

- The average interest rate on bank deposits rises by 5 basis points, up to 1.53% in June.
- The average rate of return on household deposits reaches 1.70%.
- > The remuneration of NFC deposits stands at 1.32%, driven by both the rise in rates on term accounts and the more limited rise in rates on overnight deposits.



Remuneration on deposits with monetary financial institutions






Households and NFC's deposits with agreed maturity


