Interest rates on bank deposits – France • October 2023

- The average interest rate on bank deposits continues to rise at 1.73% in September, up from 1.67% in September, to compare with an average rate of only 0.80% one year ago.



For the different types of deposits, including step-up deposits, they correspond to the average conditions practiced during the month under review by the French credit institutions on deposits of non-financial corporations and households (including non-profit institutions serving households) residents.
- In addition to the households' and NFC's deposits, the global deposits remuneration rate includes other money-holding sectors (other general government, insurance corporations, non-monetary market funds, investment funds and securitization vehicle)
- Regulated rates passbooks include passbooks A, blue passbooks, sustainable development passbooks, home savings plans, youth passbooks and people's savings passbooks.




Remuneration on deposits with monetary financial institutions


Households and NFC's deposits (in %)
