

Interest rates on bank deposits – France • August 2019

Deposit interest rates fall slightly further in August

The average interest rate on bank deposits decreases very slightly in August and falls below 0.60% (0.59%, down from 0.60% in July). This rate has decreased by 5 basis points over a year, down from 0.64% in August 2018. The interest rate on deposits with agreed maturity over two years has fallen by 29 basis points for households and by 22 basis points for NFCs over a year.

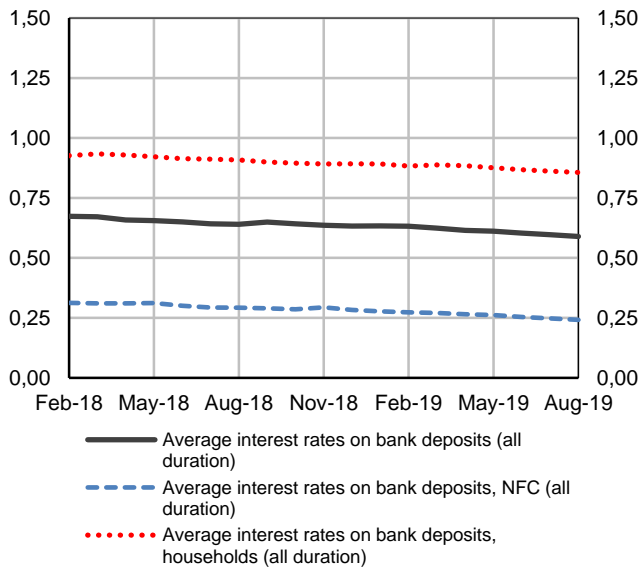

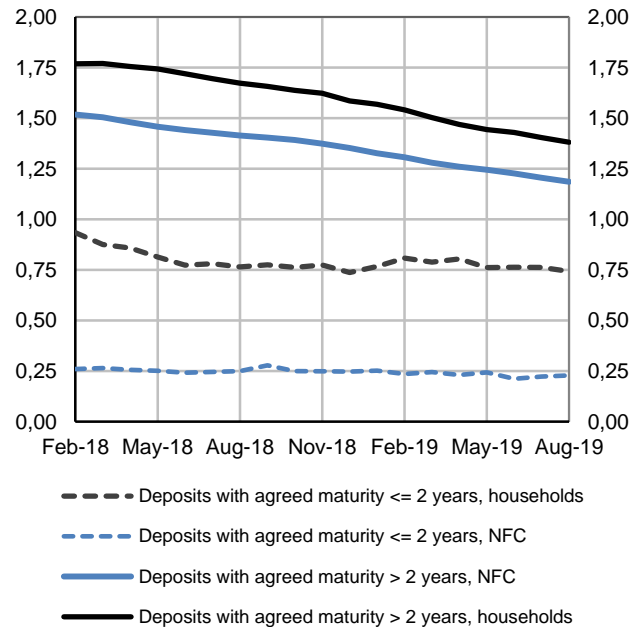

Remuneration on deposits with monetary financial institutions

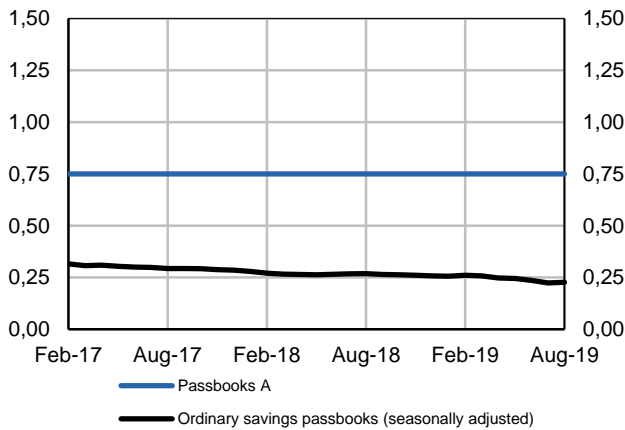
Households and NFC's deposits (in %)



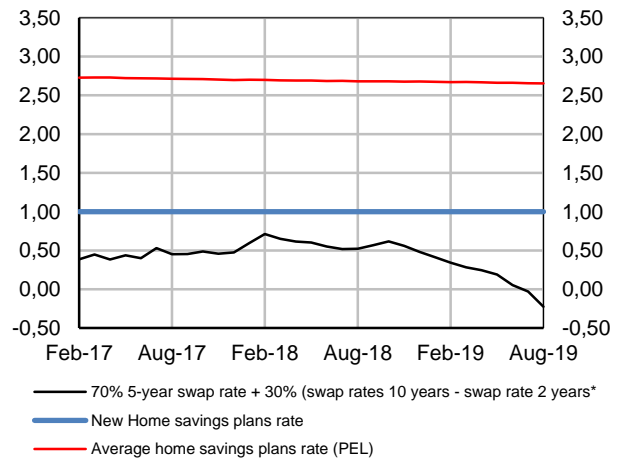
Households and NFC's deposits with agreed maturity by duration (in %)
