## Interest rates on bank deposits – France • June 2018

### The average remuneration of households bank deposits at 0.91%

In June 2018, the average gross interest rate (before taxes and social contributions) on bank deposits is stable at 0.65%. The most noticeable developments stem from the deposits with agreed maturity up to 2 years held by households (minus 4 basis points) and the deposits with agreed maturity over 2 years held by the NFCs (minus 2 basis points). Home saving plans opened several years ago continue to drive upwards the average remuneration of households' bank deposits.

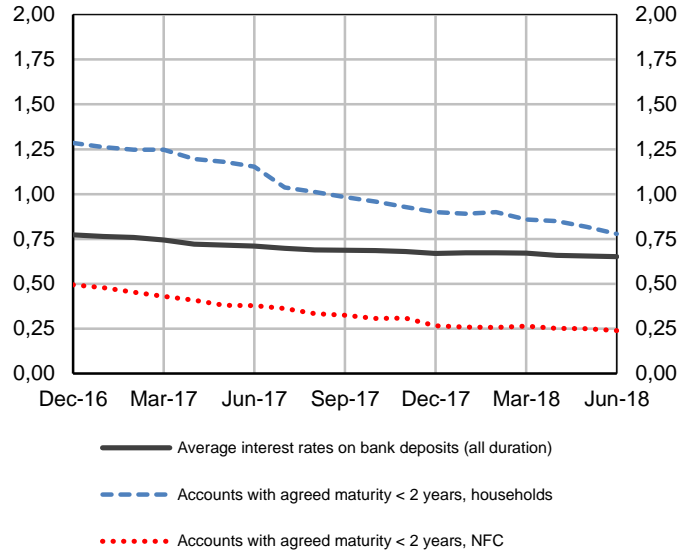

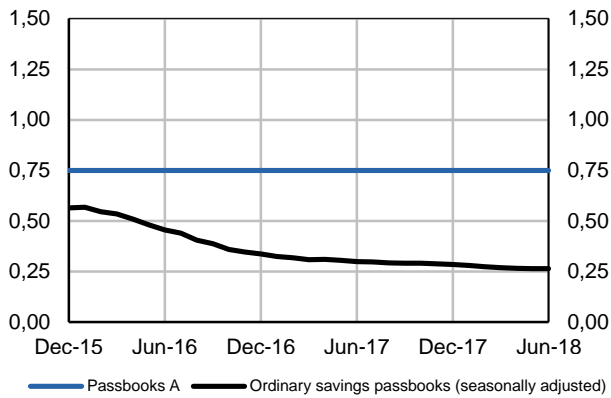

Remuneration on deposits with monetary financial institutions

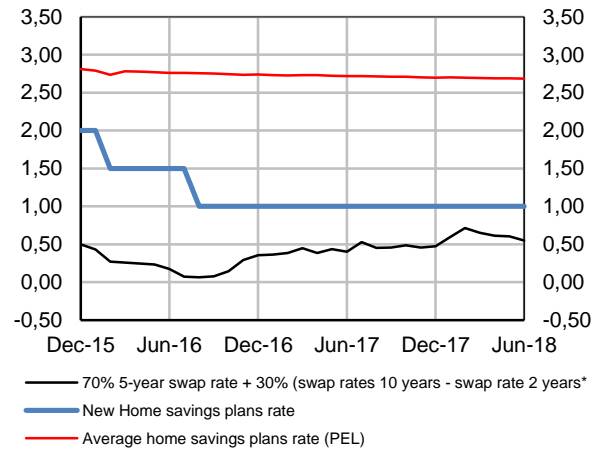
Accounts with agreed maturity up to 2 years and deposits, seasonally adjusted
