

Interest rates on bank deposits – France • October 2022

Interest rates on bank deposits continue to rise in October

- The average interest rate on bank deposits rises to 0.80% in October, up from 0.74% in September.
- The rise in interest rates is mainly driven by NFC deposits, whose remuneration stands at 0.28% after 0.16% in September.
- The households deposit rate stands at 1.15% in October, after 1.12% in September.

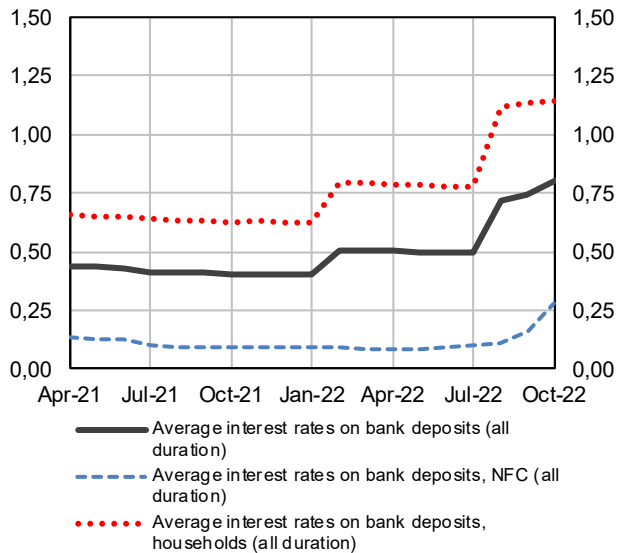

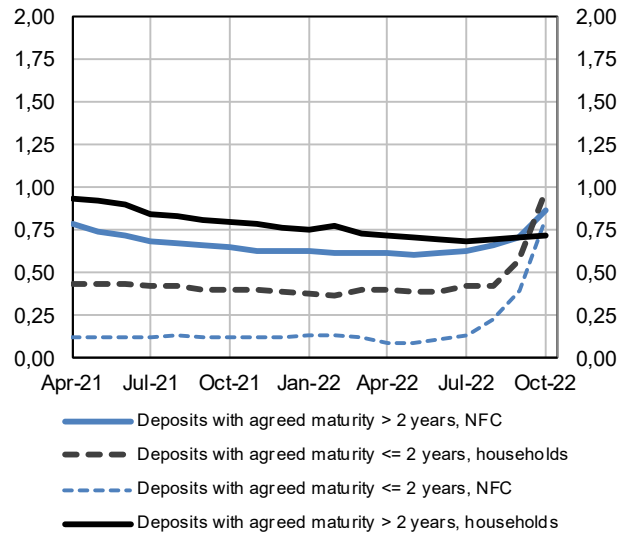

Remuneration on deposits with monetary financial institutions

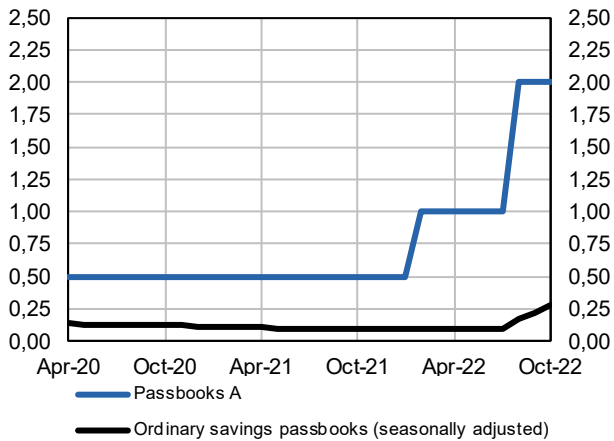
Households and NFC's deposits (in %)



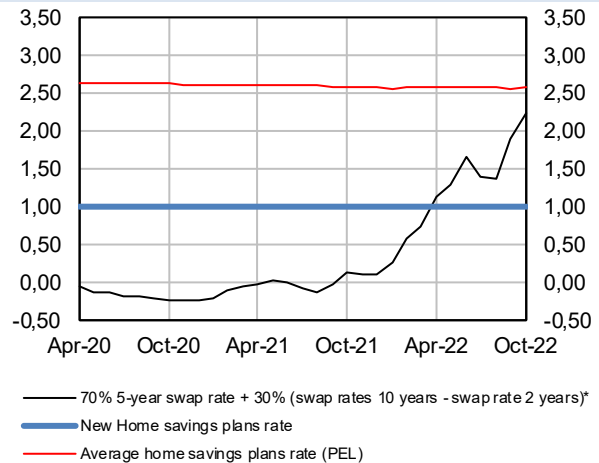
Households and NFC's deposits with agreed maturity by duration (in %)
