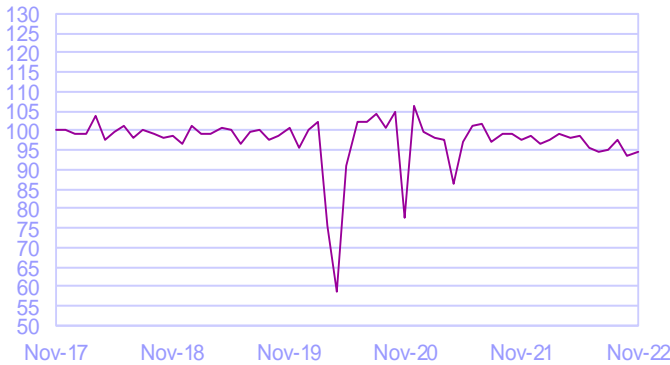

The Fedev and the Banque de France work together to publish figures for distance sales (excluding food). The last published figure covers June 2022. The figure for July will be published as soon as it is available.

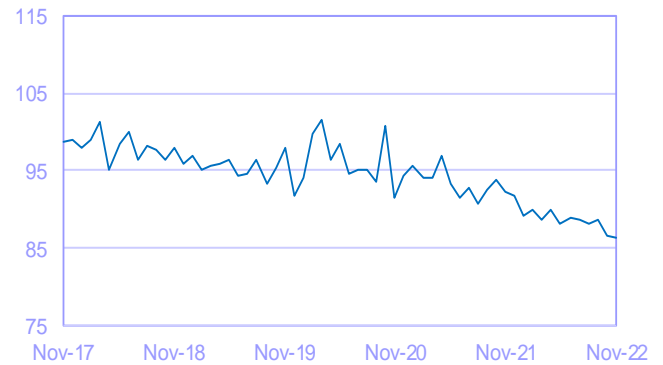
Retail sale – Total

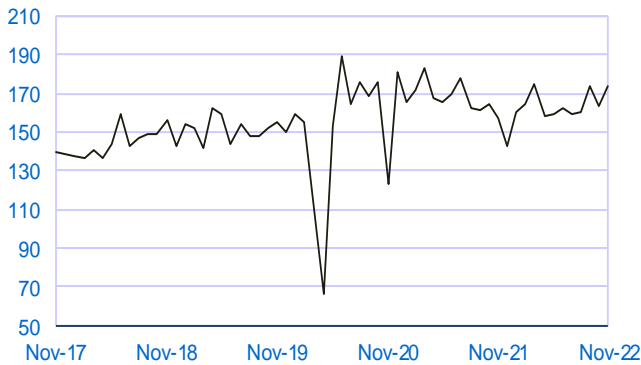

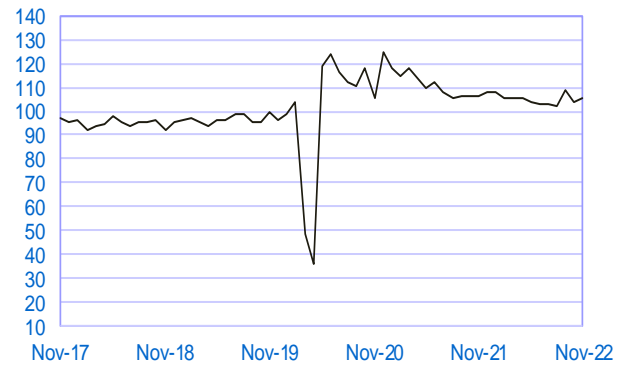

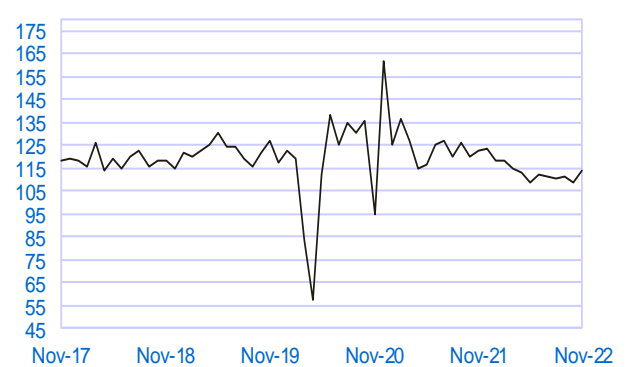

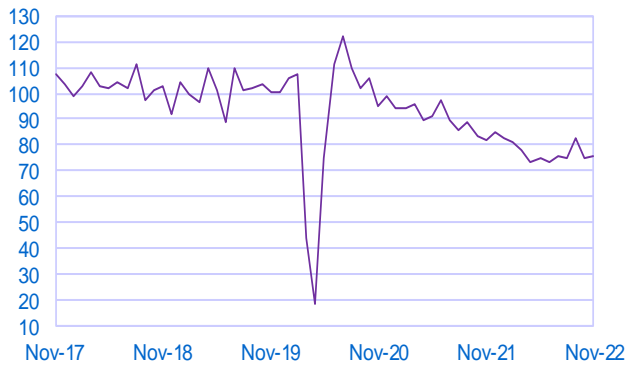

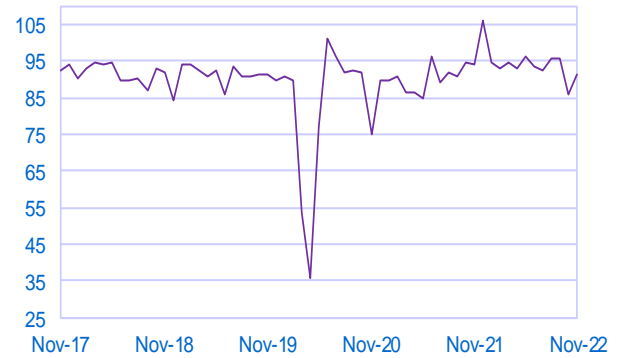

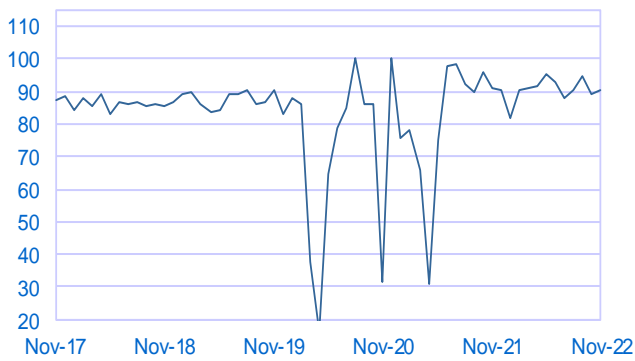


Automobile equipment (3%)

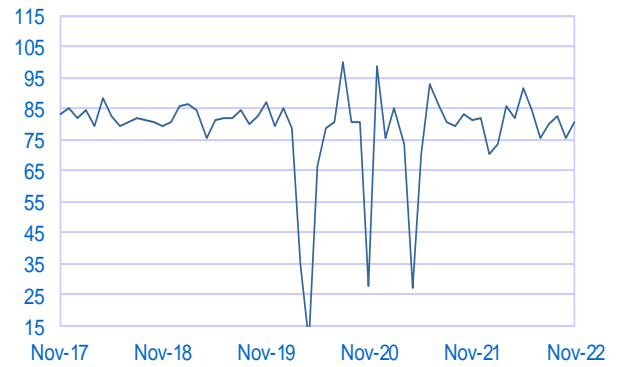

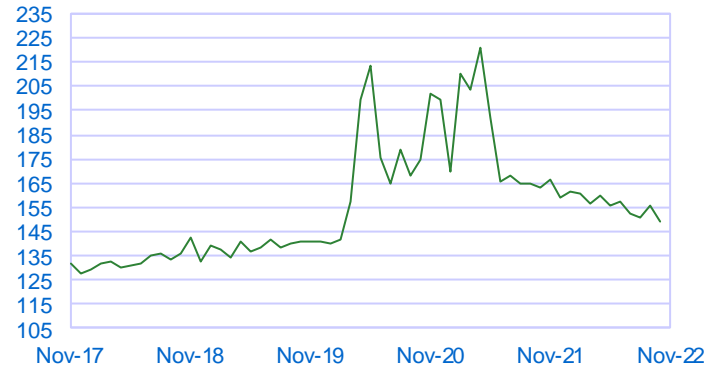
