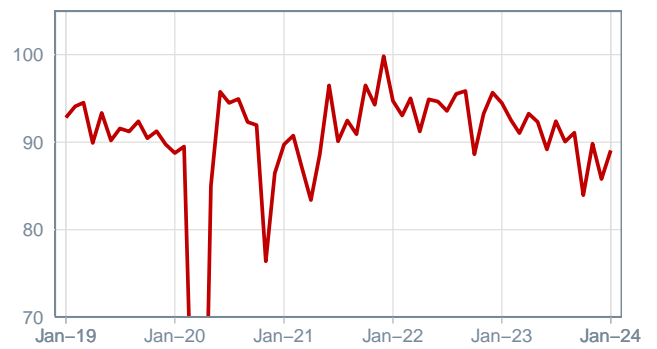

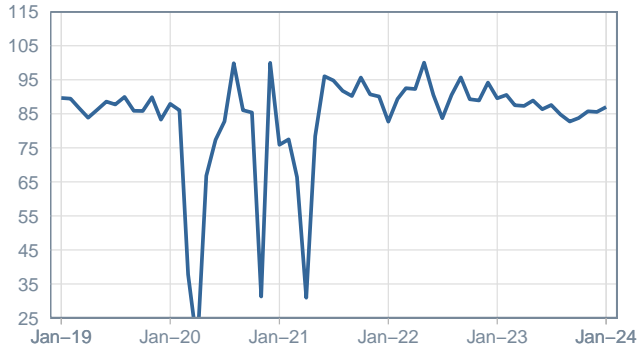


Automobile equipment (3%)

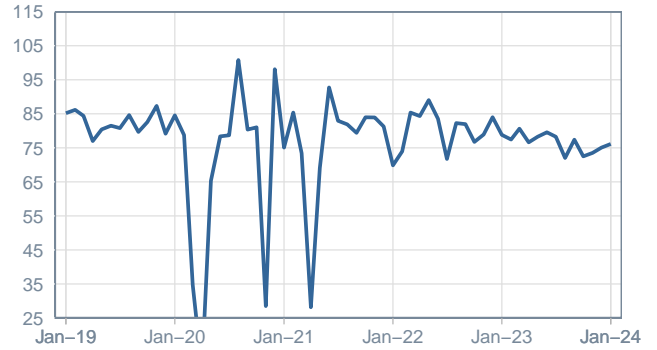

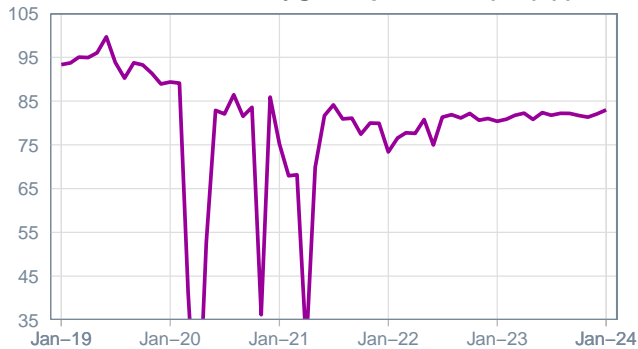
