
Balance of payments – France • September 2024

In September, the current account deficit (seasonally and working-day adjusted data) reached EUR 2.1 billion (after a deficit of EUR 1.2 billion in August). The deficit on trade in goods widened to EUR -6.9 billion (after -6.4 billion in August), and the surplus on trade in services fell (4.6 billion in September after 5.1 billion in August). On a cumulative basis over 12 months, the current account deficit narrowed to EUR 10.9 billion in September 2024 from a deficit of 36.9 billion a year earlier, due to a less negative trade balance (mostly explained by lower energy bill).

The financial account (cumulative data over 12 months) showed net capital inflows of EUR 45 billion in September 2024 (the same level as in 2023). Portfolio investment recorded net inflows of EUR 62.1 billion over 12 months, compared with 151.7 billion in September 2023. Cumulative net outflows of direct investment over 12 months reached to EUR 6.7 billion in September 2024.


